Provider Information about Service Delivery and Pricing

Toosey provide home care packages for Level 1,2,3 and 4 consumers. The types of services Toosey offer includes:

- Personal care assistance-for example, hygiene, dressings, and mobility
- Assistance with meals assistance with meal preparation
- Assistance with continence management -use of continence aids and appliances
- Nursing, allied health and therapy services
- Personal and transport assistance-for example personal shopping and attendance with appointments
- Management of skin integrity- for example assistance with wound dressings
- Assistance with purchase of clinical or assistive equipment

Consumers and/or families will be consulted and included in ongoing consultation to ensure the service they receive meets their needs.

Home Care Package Budget

- Services and care to be paid form package funding.
- A personal budget is developed in consultation with the consumer.

Each month consumers personal budgets are updated. A copy of the <u>Consumer Directed Care</u> <u>Statement</u> is sent to each individual consumer.
